Dear ICCI Members, Assalamu Alaikum;

It's our privilege as the election committee for 2024 to make the following announcement:

1. The election for Six (6) **Directors** and One (1) **President** will be held on Saturday, January 27th, 2024 according to the ICCI by-laws and the nomination procedures. Please note that the elections will be performed electronically at the ICCI.
2. Key dates for the election process have been established as follows:
 - a. Monday, January 15th, 2024 - announcement of the election and open the nomination process.
 - b. Monday, January 22nd closing the nomination at 8:00 PM.
 - c. Wednesday, January 24th, 2024 – election committee announces the nominees who accepted the nomination.
 - d. Saturday, January 27th, 2024 - Election Day, starts at 5:00 PM and ends at 9:00 PM
3. Membership dues should be paid no later than 8 PM on January 26th, 2024.
4. Membership dues can be paid by person or online at (<https://icccenter.org>)
5. Please use the attached form to nominate Six (6) **Directors and One (1) President**.
6. The form must be **received** by the election committee no later than 8:00 PM by Monday, January 22nd, 2024. No nomination forms will be accepted after 8:00 PM.
7. The proxy form will be available at the ICCI office starting January 22nd, 2024. Please note that the proxy forms are due at the ICCI main office no later than January 26th, 2024, at 8:00 PM.
8. All proxy forms have to be original, signed and the ICCI stamp on it. No copies of the proxy forms will be accepted.
9. **No member shall vote on behalf of more than one member by proxy.**
10. **Voting by proxy is limited to immediate family members only (spouse, children, parents and siblings).**
11. ICCI by-laws states: "Qualifications of Director shall include Islamic beliefs and practices, voting member of ICCI for at least two consecutive years prior to election, a good standing within the Muslim community, and familiarity with organizational work."
12. Please do **NOT** nominate the **election committee members**:
